Activity Report for TFN Newsletter

From Harley Wylie – Special Initiatives and Projects Hello,

Some people remember me, some are not familiar that I am also a Tseshaht member that grew up on Tseshaht and in the Alberni Valley. I've been away from home for over 40 years now, working in private sector as a machinist/aircraft machinist and a lot of work, decades, in government funding and contract administration, friendship centre/s, non-profit societies and other work either within a First nation or to serve urban Aboriginal community. And I'm glad to have had that type of experience that I can bring back home now. As this is being written I've been informed by our Chief that other community motions are being reviewed and listed, so that she can list, prioritize and determine who will work on them.

In May I was hired to work as the Acting Executive Director, as Wendy Gallic was on medical leave. Wendy has since returned and my duties have changed to work on special projects, special initiative, funding applications and have taken on some specific tasks. Some of these are listed below, and a short description of what is involved or has been done.

- Local Education Agreement (LEA) participate in committee meetings to attain a more supportive and accountable education system for Tseshaht and other First Nation students; there is a lot of Tseshaht/Nuu-chah-nulth money put into SD 70 and we want to see more success and graduation rates of students;
- Enhancement Agreement work will begin after SD 70 and NTC/TFN finalize the LEA;
- Protocol and other Agreements participate and contribute to agreements with City of Port Alberni (CoPA), Port Alberni Port Authority (PAPA), Alberni Clayoquot Regional District (ACRD), USMA, and other First Nations in area;
- Economic Development Corporation will be reviewing what work has been done to form the TFN Economic Development Board, progress made, and what else is required;
- Tribal Journeys Helped coordinate welcoming and providing a meal to Tribal Journey
 participants. This took place on Nettle Island and some information posted on facebook;
- Harbour Quay liaising between TFN and CoPA; working with CoPA to create a Tseshaht presence in Harbour Quay; consulting with TFN Language & Culture Committee;
- Museum Tripartite Agreement CoPA is pursuing a tripartite agreement to operate and manage the Port Alberni Museum. This would change the museum into a non-profit

- society and have TFN as one of the 3 bodies managing and operating the museum. TFN is currently assessing the option, responsibilities, liabilities etc.;
- TFN Terms of Reference Work has been and continues to be done to establish a
 professional and productive way for TFN to interact and do business for community.

This is a short list of some activities that I am participating in with TFN administration and council, and I will provide updates in future newsletters.

BACKYARD FIRE SAFETY TIPS

Sitting around a fire is a summer pastime that many enjoy. It is important to practice safe fire etiquette. Read below to learn tips on how to have a successful and safe backyard fire;

Preparing Your Fire

- Only build a fire in enclosed, contained areas such as outdoor fire bowl or a fire pit, taking care not to overload it.
- Make sure the pit is on a flat surface in an open area. Do not set up a fire pit
 underneath trees or too close to buildings to avoid anything accidently catching on fire.
- Check wind direction before lighting the fire. Wind direction can control the strength of the fire.

During the Fire

- Clear the area around the fire pit, in case of random sparks. Dry paper or grass can
 easily catch on fire if they are surrounding the pit.
- Move furniture away from fire pit as well to avoid burns from sparks.
- Many fire pits offer fire pit screens to hold back sparks, this is a great option to keep safe, especially if children will be around the fire.
- Keep flammable liquids far away from the fire pit. The heat alone can cause the liquids to catch fire.
- **NEVER** use garden waste or garbage in a fire. These items produce harmful black smoke into the air.
- Make sure a first aid kit is always nearby to treat minor burns.
- ALWAYS keep a fully charged fire extinguisher or hose nearby to quickly put out a fire in case of an emergency. Think ahead; have a plan if something does happen.
- NEVER leave children unsupervised.

Putting Out the Fire

- NEVER leave a fire unattended. Even the smallest fire can grow into a large one
 without supervision.
- Make sure the fire is completely out before you leave it unattended. Never leave a fire to die out on its own.







AN IMPORTANT UPDATE FROM FIRST NATIONS HEALTH AUTHORITY ABOUT A CHANGE IN DRUG BENEFITS FOR FNHA CLIENTS

On October 1, 2017, the FNHA will join BC PharmaCare.

The aim is to bring drug benefits decisions closer to home in British Columbia, and increase ease of access to your benefits and services.

You might be asking, what will this mean for me? For most clients things will be the same at the pharmacy counter. For very few clients, there could be a change related to specific drugs. To find out if there is a change to your medication, please visit our website at www.fnha.ca. If you have additional questions about your prescriptions talk to your doctor or pharmacist.

As always bring your BC Services Card and Status Card to the pharmacy to access your drug benefits.

If you are travelling out-of-province, please plan ahead and fill your prescriptions here in British Columbia before you leave. PharmaCare is a BC program, and cannot pay for your prescriptions in other provinces. In most cases, you may be eligible to receive in advance a supply lasting up to 100 days. Speak directly with your pharmacist to find out more.

Your FNHA is working to ensure that there is no disruption to service. Further updates will be provide closer to the transition. Some drug coverage changes are coming for First Nations in B.C.

BC PharmaCare program welcomes First Nations

First Nations in British Columbia are about to become the first in Canada to join a provincially-based prescription drug program.

Starting October 1 of this year, First Nations Health Authority clients with active Medical Services Plan (MSP) coverage will be eligible for the BC PharmaCare program.

If you have your MSP enrolled through FNHA, the move is automatic. A very small number of clients do not have MSP paid for by FNHA and will continue to have interim coverage with NIHB, ensuring you will get the drugs you need. To enrol in MSP, just contact your FNHA representative as usual.

The transition to PharmaCare is part of an overall plan to bring decision-making about health benefits closer to home and into the hands of First Nations. Bringing the program home to B.C. is our first step in improving it.

We ask that FNHA clients continue to take both their BC Services Card (or CareCard) and Status Card to the pharmacy when filling prescriptions.

Our current clients will continue to be eligible under PharmaCare for the medications they need - but a small number of recipients may have to change to a different comparable drug. If this happens to you and you have any concerns, please discuss it with your doctor or pharmacist.

We suggest that anyone preparing to travel out of province should plan ahead and fill prescriptions here in British Columbia before leaving. PharmaCare is a BC program, and cannot pay for prescriptions filled in other provinces. In most cases, clients are eligible to receive an advance supply lasting up to 100 days. Anyone needing more information before travelling should speak directly with a pharmacist.

The eligible child is covered for the following <u>coverable</u> NIHB {Extended Health Benefits} programs as listed below <u>for up to one year under the current status parent or status guardian</u>: pharmacy; dental; equipment and supplies; vision care services; medical patient travel; as necessary mental health services, and when required the Medic Alert Program. The BC provincial Medical Services Health Plan MSP Care Card is to be initiated and processed soonest — since birth children are covered for a maximum of three months under their parents/guardian - after which time, the parent/guardian will be billed for doctor visits and other eligible hospital services under provincial MSP Care Card.

Therefore, parents/guardians are strongly encouraged to register their immediately upon birth for both the Status Card and MSP Care Card.

Your CareCard, and more.

Starting February 15, 2013, the BC Services Card will replace your CareCard.



The BC Services Card

Starting February 15, 2013 the provincial government will introduce the BC Services Card, which will be phased in over a five-year period. The BC Services Card replaces the CareCard and can be combined with your driver's license. It is secure government issued identification that British Columbians can use to prove their identity and access provincially-funded health services. In the future, the BC Services Card will provide inperson and online access to other government services

Most eligible adult B.C. residents will be required to prove their identity and renew enrolment in the Medical Services Plan (MSP) before 2018; most BC Services Card cardholders will be required to renew enrolment every five years. You can simply enroll when renewing your driver's license. And even if you don't drive, you can enroll at the nearest location where driver's licenses are issued.

Exemptions from renewal of enrolment in MSP:

Some MSP beneficiaries do not have to renew enrolment:

- Adults aged 75 and older are not required to renew enrolment in MSP, but may apply for a BC Services Card when they renew their BCID or driver's license;
- Children less than 19 years of age are not required to renew enrolment in MSP and can continue to use their CareCard; and,
- Adults living in residential care or exempt for health reasons are not required to renew enrolment in MSP and can continue to use their CareCard.

CareCards and Gold CareCards can continue to be used to access provincially-funded health services until 2018.
