## MEMBERSHIP SERVICES COMMITTEE

Council Representative: Eunice Joe

The Membership Services Committee work on recommended revisions to the Tseshaht First Nations Membership Code (1987) is ongoing.

A joint meeting between Tseshaht Council and the Membership Services Committee was held July 17, 2018 to review recommended revisions. The following recommendations were made at the meeting:

- → Clarify consultation on drafting of the historical context section
- → Remove the text of the Draft Tseshaht Vision (from the Draft CCP) and replace with a note that this section will be added once the final Vision is adopted by Tseshaht Community
- → Shorten preamble and combine with goals and objectives
- → Correction to enactment by Tseshaht Community NOT under the Indian Act
- → Note that this code replaces the Tseshaht Membership rules 1987
- → Clarification on the maintenance of the membership list
- → Clarification on the establishment of a Committee to review applications for

- membership, make recommendations in respect of such applications and carry out the purposes of the Membership Code.
- → Clarification on points with respect to entitlement to register
- → Further discussion needed with respect to adoption of children

The Committee and Council plan to continue working on the Membership Code at a joint review that will be held in September 2018.

The Committee continues to consider membership additions, transfer requests under the current (1987) Membership Code. Work is also underway to update the Committee Terms of Reference to more clearly define the Committee mandate, roles and responsibilities, staff supports, meeting frequency and incorporate alignment with the Tseshaht Vision statement (as reflected in the draft Comprehensive Community Plan). The next Membership Services Committee meeting will be scheduled in September 2018.

## PERSONNEL COMMITTEE

Since May, the Executive Director and Committee have completed recruitment for the positions of Office Services Assistant, Communications & Welcome Center Coordinator and Social Development & Health Administrative Assistant positions.

The Executive Director and Personnel Committee recognize the need for a review and update to the Human Resources Policy and Terms of Reference to reflect current organizational structure and to more clearly articulate recruitment processes.

## ECONOMIC DEVELOPMENT

#### Corporation

Once all legal and technical work is complete, the Executive Director will be working with a legal team to bring several options to Leadership in terms of structure for the Board of Directors of a Tseshaht economic development corporation. It is everyone's hope to get the corporation off the ground in the very near future. A future goal includes hiring a CEO for our future corporation.

#### **Current Businesses**

As you are aware, Tseshaht has various successful forestry and fisheries licenses/businesses, as well as the Tseshaht Market. Tseshaht is happy to see our partnership with Coast Outdoor billboards come to fruition this summer with four new billboards along the highway. Some important notes regarding the billboards:

- → No funding from the Nation was used in the construction or will be used in the maintenance of the signs
- → If you are interested in advertising on a billboard, Tseshaht does not administer the rentals. Go to www.coastoutdoor.com for more information

→ Revenue generated from the billboards will be used for Tseshaht Title and Rights, as directed by a motion made by the community

#### **Potential Opportunities**

Catalyst Lands and Sproat School

At the direction of the community by way of motion, Tseshaht hired a consulting firm with almost full funding to do a *Highest and Best Use Study* for these two lands that are off-reserve. Once the report is received it will be reviewed with Council with recommendations on next steps. These both have potential prospects but the studies will serve to determine the most opportune use for these lands. They are unique in the fact that they are not reserve lands but are adjacent to Tseshaht IR#1.

#### **Exploratory Opportunities**

Working Group

Staff and council have come together as a working group to provide recommendations to Council on various business opportunities. This approach has been very effective and the next working group meeting will be open to community members to attend and observe. The meeting date will be announced when it has been scheduled.

Tseshaht is exploring the following potential business opportunities and would bring them back to the community if support is required:

#### Sand Pit

Tseshaht is exploring the sand pit site at Bell Road and Hector Road which has been inactive for a number of years. While sand exploration may not bring in a lot of own source revenue, the opportunity to clear the land for future development could be very beneficial.

#### Cannabis

Membership gave direction by way of motion to

explore both growing and selling recreational (once legal) and medicinal cannabis. Tseshaht will now engage with credible businesses and have a special meeting for Membership to learn about the options for both sectors of the industry. We hope to have this community meeting before Christmas.

#### Value-Added Wood Products

Tseshaht has recently been approached with a potential partnership for the production of value-added wood products.

## GOVERNMENTS AND ORGANIZATIONS

#### City of Port Alberni

Ken Watts has been working along with Darren Mead-Miller, Tseshaht Executive Director and the City of Port Alberni to finalize an agreement between our two governments. A draft is anticipated to be ready in the coming weeks.

#### Alberni-Clayoquot Regional District (ACRD)

The landfill is reaching its capacity and the ACRD will be applying to the Province for expansion. Once the formal consultation process begins, Tseshaht

will require funds from the Province to formally engage the community so an informed decision can be made.

Once our City of Port Alberni agreement has been finalized it will be utilized as a template for an agreement with the ACRD.

#### **Port Alberni Port Authority**

The City of Port Alberni agreement will also be used as a template for an agreement with the Port Alberni Port Authority.

## **FUNDING OPPORTUNITIES**

Ken Watts has been working with the Executive Director to identify potential funding opportunities for tearing down Sproat School, tearing down Somass Hall, and the potential of having solar power installed on the administration building to reduce BC Hydro

expenses. Ken Watts and the Executive director were successful in acquiring funding for completion of the Membership Code and Election Code. Hugh Braker is the council lead for the work on the Code.

## **GOVERNANCE**

It is clear that Tseshaht has a lot of foundational/governance work to do. The following items continue to be works in progress. Some can be done fairly quickly, while others may take more time. They are categorized by term below for your reference regarding how long they may take to complete. Updates will be provided in upcoming newsletters and at band meetings.

#### Short Term

- → Comprehensive Community Plan
- → Governance Manual / Council Terms of Reference
- → Updates to all policies
- → Tseshaht First Nation Vision, Mission, Values and Principles
- → Custom Election Code
- → Membership Code

#### Mid Term

- → Land use plan
- → Economic development plan/strategy

#### Long Term

→ Constitution

#### WHAT IS THE PURPOSE OF OUR CCP?

The Tseshaht First Nation Comprehensive Community Plan covers a broad spectrum of topics: the use of resource lands, protection of culturally significant areas, identification of economic development zones, and plans for housing. The Plan takes a short-to midrange view (5-10 years) on land development, land protection, and growth and change in our community.

With community voice and input at the center, this CCP is:

- → "Comprehensive" refers to ALL aspects of our Tseshaht Community.
- → "Community" refers broadly to Tseshaht membership, our interconnections as relatives, spouses and grandchildren, as well as the future generations of Tseshaht people.
- → "Plan" refers to the pathway informed by the community on which we can walk together step by step.

The plan can and should be re-evaluated over time and adjusted to fit the needs of the people.
