The housing department works cooperatively to assist members in applying for funding opportunities. Funding availability can vary from year, there are no guarantees.

**Process:** There is a very specific process involved in applying for and being funded for housing projects both new and renovations. Tseshahat First Nation bases renovation program application allocation on **first come first serve basis**. Tseshahat First Nation members interested in applying will submit written request for support in applying for funding opportunities with Canada Mortgage and Housing Corporation (CMHC) and Indigenous Services Canada (ISC) to the housing department. The housing department will manage the **wait list** and communicate available opportunities once your name is next on the list. There is a very specific process and requirements for each renovation funding opportunity. Some of the basic criteria to think about is:

-  Home must be the primary residence.
-  Is your home a least 10 years old?
-  Has home been deemed unfit for human habitation by the First Nations Health Authority?
-  Must supply proof of ownership (BCR).
-  For CMHC programs your annual income must meet or be below the criteria that CMHC sets each year.
-  Has your home received renovations in the past 10 or 15 years?
