#### SUPER WOLF BLOOD MOON

On Sunday January 20<sup>th</sup>, 2019 we were treated to the sight of a rare lunar eclipse caused by the alignment of three factors: it was the year's first full moon (wolf moon), the moon was at its closest distance to the Earth (super moon) and a total lunar eclipse (blood moon). Combined this made the moon appear larger, brighter and



'blood'-red in the sky.

There will only be three super wolf blood moons this century, according to astronomers. The first took place January 20<sup>th</sup>, 2000 and

the next one won't be seen until January 31<sup>st</sup>, 2037.

Sunday's lunar eclipse was also a super moon, an event that occurs when the moon is at its closest point in its orbit around the Earth. The moon passes through the Earth's shadow causing the red color, which led to its blood moon moniker.

The wolf moon is a cultural reference to the full moon in January. Likely its name came from the wolves howling from hunger in winter.


This super moon was the first of three for this year. There will be another in February and again in March.

### **Home Insurance Information Guide**

#### Individual Home Owners

Individual home owners who <u>hold a mortgage</u> are required to maintain life insurance, property protection, and liability insurance on the dwelling while they are the registered owners and occupants. Mortgage holders are required to submit home insurance documents to the Housing Department annually. Individual home owners who <u>do not</u> carry a mortgage are responsible to obtain their own individual house insurance; we recommend all individual home owners to protect their home and contents with insurance.


#### Tseshaht Elders 65+

Where a member of Tseshaht First Nation is 65+ years old Tseshaht will cover the cost of insurance of the structure of the primary residence. Elders are responsible for obtaining insurance policies and submitting to the Housing Manager to process payment.

#### Social Housing & Band-Owned Homes

Where a member resides in a social housing Tseshaht First Nation is responsible for obtaining and paying for structural house insurance on all social housing units and band-owned homes. Members who reside in social housing or band-owned homes are responsible for obtaining content insurance to cover the loss of personal belongings. The cost of personal insurance is the responsibility of the tenant. Tseshaht First Nation is not responsible for replacing tenants' personal belongings.



Elaine is from the Syilx (Okanagan) Nation and Secwepemc (Shuswap) Nation and is a member of the Penticton Indian Band.

Elaine was raised as a child by her grandmother who spoke only the nsyilxcen language. It is this foundation that shaped her world view and the importance of connection and relationships. In 2008 she led a 4-year process in her community to create their Comprehensive Community Plan for the Penticton Indian Band. The Penticton Indian Band CCP gained national recognition and as a result has been invited to speak about their process in other communities across Canada. She also led their Land Use Planning process and created a Community Driven Economic Development Plan based on community vision. Elaine utilizes the



enowkinwixw process in all the work she does, a process that comes from her people and is used to plan for all aspects of the community.

Elaine has worked for Provincial and Federal governments as both employee and contractor for the past 16 years. She has also worked as a political advisor to British Columbia leadership, was the Chief of Staff to the BC Assembly of Chiefs Regional Chief and was recently elected to a 3-year term as the Union of BC Indian Chief's Women's Representative. Elaine is recognized and trusted for her commitment to community voice and her ability to create a safe space for all voices to be heard.

Elaine has been an entrepreneur for 20 years and has received many accolades including her first award at the age of 20 for Social Change. She has also managed, promoted, marketed and co-produced music for multi-award winning artists who travel across Canada into the most northern and remote communities to promote healthy living and gang awareness work. She is a highly-sought after motivational speaker who understands the importance of self-leadership in business and personal development and enjoys working in community to promote healing and wellness through meaningful planning processes.

#### HISHUK'ISH TSAWALK



We are excited to release the third edition of the First Peoples' Cultural Council's <u>Report on the Status of</u> <u>B.C. First Nations Languages 2018</u>. This report reveals that while the number of language learners continues to increase, there are still serious threats to language vitality with an ongoing loss of aging fluent speakers and challenges accessing language resources. While B.C. language revitalization efforts continue to face many challenges, there has also been positive progress with the development of federal language legislation, increased investment from the B.C. government, a growing interest in language revitalization, and an increasing number of people — especially young people — who are learning and speaking their languages.

#### 2018 Current Language Status from 177 of 203 First Nations Communities in B.C.

- There are 4,132 (3%) fluent speakers in B.C.
- Fluent speakers decreased by 1,157 (4,1%) since 2014.
- 52% of fluent speakers 65+ resulting in the decline of fluent speakers.
- Younger fluent speakers (ages 0-24) increased to 117 from 54 in 2014.
- There are 13,997 (10.2%) language learners, an increase from 9.1% in 2014.
- 78.1% of learners are under the age of 25.
- 24/34 B.C. languages have been partially documented on *FirstVoices.com*.

#### **B.C.'s Unique Language Diversity**

- B.C. has more than 50% of Canada's First Nations Languages.
- B.C. has 34 First Nations languages with 7 distinct, unrelated language families.
- There are 93+ dialects within the languages.
- There are 3 languages once spoken that are now sleeping.
- Languages Indigenous to other parts of Canada are also spoken in B.C.

#### Increase in Government Support

- <u>Truth & Reconciliation Commission's</u> (TRC) <u>Calls to Action</u> support language rights and revitalization work.
- Federal language legislation is currently in development in consultation with First Nations.
- In 2018, the B.C. government made a historic investment of \$50 million, over three years, to support language revitalization efforts across the province

We are encouraged that the 2018 report points to a growth in the number of young fluent speakers and learners in the province, but also see areas where more is needed for First Nations communities in their language revitalization efforts.

It's also important to note that this work will not happen overnight, but will require stable, long-term investments in community-based revitalization programs to help turn the tide on Canada's dark colonial history of language suppression. Increased support is needed for immersive language programs at all age levels, for language recording and archiving, for strategic planning and for language programming in educational institutions.

As individuals, we can all consider the role we play in supporting language revitalization in B.C. by supporting language champions, requesting language programs in schools and communities, and advocating with all levels of government to support the TRC Calls to Action for language.


