

We are planning a Reclaiming Lost Souls of the Alberni Indian Residential School event September 27 & 28, 2019. We cannot do this event without the support of our own community. We invite you to come and have some chumus and talk with us about this event and what that looks like for Tseshaht.

We hope to see you there!



Over the last few decades we have come to know there are many "**lost souls**" trying to find their way home culturally. There is much healing that needs to take place. We recognize many Nations may have had children who attended the Alberni Indian Residential School, some of which may also have passed here, and we would like to spiritually facilitate a way for them to go home in peace.

Port Alberni BC

We are currently planning to host any Nations in BC who would like to attend our **healing event**, beginning at daybreak with a Yuxshitl "traditional brushing" of the former Alberni Indian Residential School lands. Once the Yuxshitl has been completed through proper Tseshaht protocols we will give our traditional permission for any Nation in attendance to perform their own cultural cleansing of these "**lost souls**" in hopes they will go to their ancestral homes in peace.

This practice will be emotional for everyone in attendance and we plan to have our Nuu-chah-nulth Quu -asa team in attendance for cultural support and brushings. We have invited all Nations from across BC to extend an invitation to their own cultural support team to attend for cultural consoling and supportive participation as we understand not all supports are the same from Nation to Nation.

The two-day event will close with a Tseshaht traditional feast with singing, drumming and dancing to respect the memories and celebrate that **we are still here**.

We hope to have as many Tseshaht in attendance as possible in order to show that we, as a Nation are looking to take back our land and move forward in a positive direction.



- June 24-26, Linsey and Dawn along with several Tseshaht members attended the *International Indigenous Language Conference* in Victoria. Here we attended presentations focused on language fluency approaches and were able to network with language learners, program coordinators, and funders. The information gathered during this conference and the personal connections made will lend to our Tseshaht Fluency Strategy.
- July 6-20th, two intensive immersion classes as a part of the Quuquuatsa Language Society and UVic's Indigenous Language Revitalization Diploma program were hosted in Tseshaht territory. Tseshaht donated the longhouse and haahuupayak gym for the Nuu-chah-nulth cohort. Linsey as a part of her position attended these two weeks as a learning opportunity. Linsey and Dawn facilitated one of the two courses over the two weeks.
- A Team-Based Mentor-Apprentice presentation at the Language Conference by the Sauk language group and the Mentorship course as a part of the two-week UVic program inspired a test-drive of a Team-Based Mentor-Apprentice approach for advanced learners of the Barkley dialect during August for two days a week. At this time there are four cisaa?ath learners and one learner from yuułu?ił?ath and huupacasath Nations. The goal of this approach is to create an immersion environment, build confidence in learners to become conversational, and for Tseshaht to be leaders in building and supporting a Barkley speaking language community. By test-driving this model, we hope to learn a lot and create more language learning activities that can be brought forward to other learners.
- Grant has been working hard to do an assessment of all the language resources and recordings Tseshaht has. He is reviewing the Tseshaht Words/Phrase booklet and the TaaTaaqasapa dictionary and cross-referencing it with what is currently available or not available through our FirstVoices Porthole. Grant has been doing recordings to fill audio gaps currently found on our FirstVoices page and reviewing language with Willard Gallic. He has also been cleaning up old sound files he has found.

WORKING TO BUILD SAFER, HEALTHIER, INDIGENOUS COMMUNITIES

DRYWALL/GYPSUM WASTE DISPOSAL INFORMATION

When delivering your drywall to the AV Landfill, certain procedures will need to be followed. A Gypsum/drywall waste disposal application is required for the disposal of all drywall/gypsum material. Applications can be downloaded from https://www.acrd.bc.ca/alberni-valley-landfill

Or picked up a paper copy at the Landfill. The following provides the acceptance instructions:

Gypsum/drywall: (no asbestos)

Complete the waste disposal application form.

 Bring the completed form with any necessary documentation and material to the Landfill for onsite verification and disposal.

Gypsum/drywall: (with asbestos)

- 1. Complete the waste disposal application form.
- Bring the completed form with any necessary documentation and material to the Landfill for onsite verification and disposal.
- Follow the legal requirements for bagging asbestos material for disposal:
 - Carefully place asbestos containing items in the required 6 Mil poly asbestos disposal bags available at the Alberni Valley Landfill for \$2 or \$3 each
 - DO NOT overfill the bag—leave enough space to properly tie it.
 - Wipe the outside of the bag clean with a wet paper towel and dispose of it with your material
 - Tie the outside of the bag goose neck style and seal with duct tape
 - Place the sealed bag in a second asbestos disposal bag and repeat cleaning the outside of the second bag and sealing with a goose neck tie.



TSESHAHT CHIEF COUNCILLOR'S REPORT

With a little over 9 months remaining in our term as elected Chief and Council it is important to take a moment and look back on the work that has been done to date as well as review our current list of projects and next steps. It continues to be a pleasure to work with council, staff and community members to create more opportunities and supports for our membership. It is always important to remember that every individual brings their own knowledge and strengths contributing to the collective vision. We recognize that there is still so much work that we all need to do but also want to recognize all the ones before us that have helped get us to where we are today.

POLICY AND PROCEDURES

Council has identified the need to develop, update and review current policies that we have in place. It is important that our policies reflect our values as Tseshaht, providing fair and consistent direction for our council, staff, committees and members to follow. In our Council strategy session in December 2018 we identified several policies that need to be in place and up to date with our facilitator Ainjil Hunt. We are very saddened with the passing of Ainjil and would like to thank her family for sharing her in her work with Tseshaht First Nation and her close ties to many of our community members. Our council and administration will continue to work to identify a consultant and funding to complete this very important policy work. Here are some of the policies we identified: housing, facility use, credit card, contracts, communications, elders,

fisheries and wildlife, education, cannabis, forestry, electronics and email use, donations, parks, garbage and recycling, businesses on reserve.



It was also prioritized to update our current Human Resource Policy and develop a bullying and harassment policy. We have successfully received funding to do this work and will be working with a consultant.

In addition to the policy work, we continue to work on our Comprehensive Community Plan, Custom Election Code and Membership Code. These are very important documents that have taken much time and the efforts of many to bring them to where they are todav. The current Comprehensive Community Plan is a combination of the draft from 2010 and 2016. We were successful in receiving a significant amount of funding to continue to engage our membership in the development of our CCP. Our CCP Champion is continuing this work in our community and will provide updates regularly. Our membership services committee, council and staff continue to work on the final draft of the membership code and have been reviewing specific matters with legal representatives.

HARBOUR VIEW LANDS

A request for proposals was released by the City of Port Alberni for the Harbour View Lands. I have been informed that the RFP is now closed, and the City will honour their commitment to meet with Tseshaht First Nation representatives prior to reviewing the proposals and making a decision.

COMMUNITY SAFETY

The safety of our community members continues to be a priority for all of us here in Tseshaht First Nation. We are working at building stronger relationships with several outside entities to create a safer

community. One is the local RCMP. We have 3 Indigenous Policing Officers that we work with closely to improve the safety in our community and continue to look at im-

proving what services are already offered. It has also become apparent that we must also improve our relationships with Crown Counsel and Probation Services to ensure we are consulted about offenders living within our community. As we continue to heal from the traumas of our past and present, we want to ensure that all of our members are supported in their healing journey. It is important that we provide

the safety and security for our children that is needed. We thank the community members that continue to advise on their safety concerns so they can be addressed accordingly.

In the consideration of community safety there are several other initiatives and projects that we have been reviewing. One that has been completed was the slope stability that was identified in one of our storm seasons on Old Logging Road off McCoy Lake Road.

Other initiatives/ projects include:

- ✓ Traffic signs the 3 new stop signs at Ekooth and Tsuma-as Drive
- ✓ Walkways created on Tsuma-as Drive and Hector Road
- ✓ Speed limit reduced to 30km/ hr on Hector Road and Tsuma-as Drive

Some other areas we continue to lobby for include better lighting along our roads, walkways on McCoy Lake Road and Pacific Rim Highway.

BC GAMING REVENUE SHARING WITH FIRST NATIONS

We have recently received the packages with information on how to sign on to the limited partnership. The provincial government has transferred \$194.84 Million to the First Nations Gaming Revenue Sharing Limited Partnership with distribution expected to be made soon. The split between First Nations in British Columbia will be based on 50% divided equally, 40% based on population, and 10% remoteness formula. We have made it a priority to engage staff, council and community to prioritize these funds based on the following conditions set by the Government; health and wellness, infrastructure, safety, transportation and housing, economic and business development, education, language, culture and training, community development and environmental protection, and capacity-building, fiscal management and governance.

RECONCILIATION

At the beginning of our term it was recognized that we need to build stronger relationships to ensure that our Nation is included in the decision-making processes within our territory. There are a number of ways that we continue to advance our presence and involvement and one way has been through the development and implementation of Protocol Agreements. We have successfully adopted a Protocol Agreement with the City of Port Alberni and the Port Alberni Port Authority. In addition to the Agreement with the Port Alberni Port Authority, we took the lead on lobbvina for First Nations Representation on the Port Alberni Port Authority. Since our lobbying efforts there are now 2 First Nations representatives (myself included) on the Port Authority and efforts continue to lobby for permanent First Nations representation. There are a number of other protocol agreements we would like to develop including one with USMA, ACRD, and other First Nations (especially those operating within our territory).

As we continue to explore what reconciliation means and looks like for Tseshaht First Nation there are many discussions and efforts being made at several levels of government which we continue to take part in. At the municipal level we have been involved in the work of the reconciliation committee working to advance reconciliation in the Alberni Valley. We will provide a more in-depth update to our community members in the Fall. At the provincial and federal level we continue to engage the governments, especially the

Ministry of Indigenous Relations and Reconciliation and push for them to honour their commitment to adopting and implementing the United Nations Declaration on the Rights of Indigenous Peoples, TRC Calls to Action and Tsilhqot'in decision.

Nuu-chah-nulth Tribal Council received funding for work on Reconciliation on behalf of the Nuuchah-nulth Nations. Shana Thomas is the coordinator on this work and we have invited her to engage our members in this work. We have also made it clear to NTC that most of this work will be done on a Nation level and not through the NTC. It is up to us as Tseshaht First Nation to decide what reconciliation looks like and how we want to engage the different levels of government moving forward.

HAAHUUPAYAK SCHOOL

We continue to work towards the vision of a Kindergarten to Grade 12 immersion school for our students. We continue to have discussions with Federal and Provincial representatives to expand haahuupayak school. Based on the feasibility that was completed in 2016 the federal government committed to provide funding for us to enter the design phase of this work. As this expansion requires a significant amount of funding it will likely be completed in a phased approach.

LANGUAGE AND CULTURE

We are very happy with the work that has been done to open our Language House in the efforts of revitalizing our Tseshaht Language. We currently have 3 members employed and working on this initiative. As council we recognize the importance that each of us have a role in the revitalization of our language and have taken it upon ourselves to learn as well. We have asked our Language Coordinator to attend every council meeting to provide a language lesson. We have also been working to have a welcoming speech prepared in Tseshaht language for when we are asked to provide welcomes at events.

ECONOMIC DEVELOPMENT

Sproat School

Following our presentation to the community on the work that was done regarding the Highest and Best Use study for this property we were successful in receiving funding from CORP for the preliminary design phase for mixed commercial and residential use for this land.

Orange Bridge Cannabis Dispensary

A Manager, Assistant Manager and Supervisor have all been hired for Orange Bridge Cannabis. They will continue to act on the steps necessary to open the dispensary.

Micro Hydro Project

With the changes to the Standing Offer Program it was not feasible to move ahead with the Micro Hydro Project. Recognizing that there was a substantial investment in time, effort and financially for this project we are currently working towards recovering what we can by lobbying the government and working in collaboration with other Nations

Alberni Ice

This project became more of a cost for our Nation than an opportunity and after careful consideration we dissolved our partnership with HUB City for Alberni Ice.

Forestry and Fisheries

Utilizing forestry funds, we were able to make a lump sum payment of \$1,000,000 towards our long-term debt which will save a significant amount of money on interest on that debt. More updates will be shared from each department in Fall 2019.

HEALTH AND WELLNESS

Tseshaht was a driving force behind bringing Mental Health and Wellness to the forefront of our discussions at many different levels. With Nuu-chah-nulth we were able to develop a Mental Health and Wellness Declaration and lobby for significant changes in supporting the health and wellness of all Nuu-chah-nulth. As Tseshaht we have also been successful in receiving more funding to support our own initiatives for our members. Through our own efforts and collaborative solutions with other organizations we continue to improve the health and wellness of our people. It is important that we continue to move forward on initiatives that will better our physical, spiritual, emotional, and mental health.

NTC BOARD OF DIRECTORS

NTC Board of Directors Meeting – July 30, 2019, Port Alberni

Following the election in Ditidaht First Nation the new NTC Director is elected Chief Councillor Brian Tate. We received an update from our Nuu-chah-nulth First Nations Health Council Representative Les Doiron. It was brought to our attention that the FNHC decided to

remove the Chair and Deputy Chair and appoint on an interim basis. Les is currently the Deputy Chair until new appointments are expected to take place on August 16. The NTC Directors reviewed and approved the March 31, 2019 audited financial statements. Motions were also made to distribute the following surpluses:

- \$786,295 Targeted Health Program to ALL Nations (25/75 formula)
- \$390,000 ISC Core Program to ARFA Nations (12.5/87.5 formula)

The NTC Constitution and Bylaws working group are in the final stages of their mandate and will be presenting proposed changes at the upcoming NTC AGM. Support was provided for the following:

 proposal to the Pew Charitable Trusts for \$200,000 in funding to support the operation of the Nuu-chah-nulth – Haida Oceans Dialogue Forum in 2019-2020.

- proposal to the Sustainable Development Goals through Employment and Social Development Canada in amount of \$100,000.
- Enter a Memorandum of Understanding with Industry Training Authority.

A motion was also passed to opt into the new Vision Care Program model that is delivered through the partnership established between First Nations Health Authority and Pacific Blue Cross. We will provide more information about these changes when they become available through Nuu-chah-nulth Tribal Council. The changes are expected to take place in mid September 2019.

Tseshaht Women's Declaration - a meeting to continue this work needs to be rescheduled.
