Provincial Health Officer - Order on Household Visitors

By order of the PHO, all households in the <u>Interior Health</u>, <u>Island Health</u> and <u>Northern Health</u> regions cannot have more than six people visit at one time. For example, if you have five people living in your household, a maximum of 11 people are allowed in the home at one time. The order applies to all gatherings hosted at households, like a large dinner party, celebration of life, wedding or baby shower.

- This includes both indoor and outdoor gatherings
- Gatherings in private homes often do not allow for the necessary space and do not have cleaning protocols to ensure the overall safety of residents and visitors

People of all ages are included in the six person limit. For example:

- Šix adults
- Four adults and two kids
- Two adults, two kids and two babies

What is a household, resident and visitor?

A household is:

A group of people who live in the same dwelling. For example:

- If you have a rental suite in your home, the suite is a separate household
- If you live in an apartment or house with roommates, you are all members of the same household

A resident is:

- A primary resident, or person who usually sleeps in the home
- A person that does not have a usual residence somewhere else

A visitor is:

- A person visiting the home
- A person who does not spend the night

Enforcement

During a public health emergency under the Public Health Act, the PHO can make orders as needed. You must follow the orders.

The PHO Order for Gatherings and Events can be enforced by police or other compliance and enforcement officials. People who don't follow the order could be fined.

- Fines of \$2,000 may be issued to hosts who do not follow the order. For example, having more than six people attend a gathering at a private residence or a vacation accommodation
- Fines of \$200 may be issued to people who refuse to leave any gathering at the discretion of police or an enforcement officer.

 We want to thank our community for adopting the Language Strategy in March and even though we are unable to gather and conduct some of the programs we were planning for this year due to the pandemic we have been able to use the strategy as our guide to direct our priorities and planning. We continue to work hard on strengthening our language over these challenging times.

The language program is supporting two Mentor-Apprentice language teams.
 The criteria for this participation is very strict due to covid requiring learners to be living in a household with a mentor and both our apprentices have

shown a commitment to learning and already have a foundation of language knowledge. Della Preston, a dedicated cišaa?ath language learner has begun doing Mentor-Apprentice and has completed 25 hours with her mentor Levi Martin. Kathaleen Good is continuing to work with her grandmother Angie Joe.

 We had 5 Tseshaht learners attending an online language intensive course offered by Adam Werle, this opportunity was promoted at our online class.



- We continue to work on our FirstVoices online archive increasing the words and phrases, adding photos, adding videos, and developing an app with FirstVoices. There is a glitch in the language app for android users at the moment, this is being worked on and we will announce on Facebook once this has been resolved.
- We have been creating short videos as learning resources these are posted on our Facebook page and YouTube page.
- We are translating the Paul Creek curriculum into our language. This curriculum will be used as part of the learning foundation for implementing our intensive program. This curriculum has been translated and used in various Indigenous communities with a high degree of success.



NOTICE RE WITHDRAWN CANDIDATES ON BALLOTS

I understand that some Voters have raised concerns regarding Candidate names appearing on the ballot after that Candidate has withdrawn from the election.

Unfortunately, this can and does happen. This is because while Candidates are able to withdraw right up to the date of the polls, mail in ballot packages must be distributed long before this date and once the ballots have been mailed out, they cannot be changed.

Given that this situation is inevitable, I routinely employ a number of strategies to minimize its impact.

- In cooperation with Administration, I post a Notice of Candidate Withdrawal whenever a Candidate withdraws.
- On polling day, I inform every voter of any of Candidates who have withdrawn but whose name continues to be on the ballot.

Hugh Braker

-25 years as a lawyer specializing in aboriginal people and the law, appointed Q.C. by the Province of BC, received the Aboriginal Achievement award for law and politics, published approximately 100 papers on the law, has made presentations at conferences and universities in the US, Australia, New Zealand, Brazil and Norway and in all parts of Canada. Chair of the Board of the NRT, President of the First Nations Fisheries Council of BC, President of the Native Courtworkers Association and previous President of approximately ten other organizations.

Claims

When I was first ran for council, I stated that Tseshaht had been taken advantage of for almost 200 years. I made settlement of Tseshaht specific claims and our land claim a priority. No other previous council had pursued all our 20+ specific claims. We are now close to settlement of our claim for the loss of Iwachis at Franklin River. I have in the past estimated a settlement of over \$10 million. I must now up that estimate to at least \$15 million. We are also negotiating to settle the forced removal of Tseshaht from our community at the foot of Argyle St. (Wolf Village). I believe that claim to be worth much more than Iwachis. In total, I believe Tseshaht will receive between \$50 and \$75 million for settlement of all it's specific claims over the next 8 years or so. I have stated several times that we can use those settlements for the costs of our land claim, other Tseshaht projects and a per capita distribution. It is a fact of life, that some of our elders may not live to see the end of our claims. A per capita distribution of some of the funds would allow all our elders, and all other Tseshaht, to see the benefit of these settlements. Our land claim is the key to Tseshaht's future. Once we control our lands, river and maritime resources we will hopefully end the conflicts with DFO, guarantee Tseshaht children jobs for the future, lift our First Nation out of economic pressures and allow us to invest in retaining Tseshaht culture and language.

Education Jurisdiction

I continue to represent Tseshaht in education jurisdiction negotiations with BC and Canada. The 14 First Nations are very close to concluding these negotiations. We hope to implement the jurisdiction next September. Haahuupayak has supported these negotiations since day 1. Over the next 5 months there will be a complex number of information sessions, votes and council decisions that the Tseshaht must make to implement the jurisdiction.

Forestry

Tseshaht is facing a number of challenges on forestry issues including simple matters such as securing firewood for elders, to far more complex issues such as the sale of TFL 44 interests to the Huuayaht. A large part of TFL 44 lies within Tseshaht territory. Ultimately, I believe our land claim will settle these issues, but until our land claim is finished in court, we must work to protect our interests in forestry.

Emergency Preparedness

As the Councillor responsible for Emergency Preparedness, we have dealt with a number of emergencies over the past 8 years including Tsunami alerts, windstorms, flooding and, now, a pandemic. I am very proud of the Tseshaht Emergency crew. Tseshaht is often called upon to make presentations as we are viewed as one of the most effective Emergency programmes for First Nations. During this pandemic Tseshaht's Emergency crew made educating and informing our people on and off reserve a priority, as well as providing effective cleaning supplies to our most vulnerable members and providing non-grocery store items such as fish, urchin, oysters, clams and mussels to our elders and some members. Tseshaht also did a per capita distribution of funds to assist all our members with extra costs. Protecting our most vulnerable members is the Tseshaht emergency crew's goal.

We will continue to reduce our debt, increase economic development and opportunities, increase transparency and accountability, support education, and solidify the mission and vision of ċišaa?ath through our CCP, governance structures, policies and procedures. Together we can continue the work of building a strong, healthy and proud community for our children. ṢaaṢaatiqamaḥ siiwa (I thank you all).

I am forever grateful to my parents for that gift.

I have done several jobs over my life from taxi driver to recreation worker to kindergarten teacher, the longest of these jobs was with our nation. I sat on the board of Haa Huu Payak School for two years. Since I left the office I have been a Caterer to many different communities and nations up and down the island. It has been its own learning experience.

I started out in 1991 as receptionist for the band. I was honored to work for the Council of the day. Four months into my position, the record keeper left and I was asked to pick up the job until they hired someone to fill the position, I did the record keeping for two years. The band manager of the day, Phil Fenn, expressed to me how important it was the I learn the running of the office, so he set me up to work in the various departments from time to time. In my forth year there I was promoted to Administrative Assistant and our Chief Councilor, the late George Watts, arranged for me to take the minutes for Council and Band Meetings as well as meetings with other governments. I did this for the remainder of my time there. Though we did not always see eye to eye, I had great respect for Mr Watts. He ensured that we brought in band members to fill positions and saw to it that we were trained to properly serve our membership. I learned a lot from him.

I have seen many changes within our office over the years, both at the council and staff lever. Change can be good and in many cases is necessary, however the base should always be the needs of our members.

After a lot of consideration I have decided to accept the nomination and thank those who believe in me. I would like to be a part of our changes and forward movement.

My mother's parents were Lizzy Cole Taylor of Squamish Nation and Dave Taylor of Tseshaht Nation, my grandfather's mother was Emma David who was a well known basket maker in her time and taught my mother's aunt Mabel Taylor.

Previously I went by my stepfathers surname and was commonly known at Darlene Gus. I grew up in an era where there were no jobs available for native women in the Alberni Valley. This caused me to leave to attend Camosun College and the University of Victoria in the midseventies. Because of my varied educational background I have worked in a variety of fields from the Robertson Creek Fish Hatchery with Fisheries Canada to the Canadian Forestry Service in Victoria, Indian Affairs in Vancouver to the Union of BC Indian Chiefs in the area of Environmental Health. My final and longest jobs were with Environment Canada as a weather observer and then a weather services specialist where I was deployed from Port Alberni, Lytton, Revelstoke, Vancouver, Kamloops and Victoria. When the jobs with Environment were contracted out I managed to get a job with Canada Revenue Agency. I worked the front counter helping people with their income tax returns and child benefit applications. Eventually in the 20+ years that I worked there I received training in Trusts & Estates and International Taxation. My mom Eva Thomas and grandfather Alex Thomas were Tseshaht. Mom moved us to Tseshaht in 1963, shortly before she died. We were raised by my uncle Bob Thomas and aunt Rose Thomas. Tseshaht was heaven compared to living in a racist USA. I was fortunate to become friends with people like the late Larry ("Bugsy") Gus, Barry Gus, JP Jones (in AIRS at the time) and others. I have great memories of playing basketball for Tseshaht against AIRS in the old barn, other sports at "The Backfield" (Haahuupayak), of being in Port Alberni Boxing Club, chosen to box publicly along with the late Pete Tatoosh, Dixie Watts; many good memories in sports and our rez'.

In the **70's** I left for Camosun College, to finish grade 10; then grade 12 and 1st year university. During 1st year I became a single parent, and was chosen to work as a Project Officer at Employment Development Branch (now called HRDC) **so didn't** return to get a degree. **I don't** regret my decision to be a single parent.

For over 40 years I have: 1) worked in government program funding administration; 2) Aboriginal non-profit societies delivering program services: and 3) in governance as a board/council member for different societies. **I've** worked with people of different cultures in social justice initiatives, accredited education curriculum, Asian/First Nation book and video and other Indigenous and inter-cultural initiatives. Good people from other cultures will work with us. My mix of education, experience on/off-reserve, in government/non-profit/private sector, with/for different cultures will benefit representing Tseshaht to deal with City Hall, ACRD, PAPA etc. and local major employers and the general public in this fair (?) city. There are many stakeholders to maneuver our way through. Tseshaht is a major stakeholder and it is time for TFN council to make that clear and act like it. I believe my experience and comfort with this process is an asset — Tseshaht is a major stakeholder and it is time to make that clear and act like it.

When working as TFN administrator it was clear we have staff with ability, experience and important knowledge of our culture and history - and history with local stakeholder issues. They greatly assisted me in important meetings with the City, ACRD etc., and worked well as a TFN team when given the opportunity. Competent staff deserves credit and opportunities to move Tseshaht forward - with a team approach we can do this.

Our community wants and deserves information on activities, finances, opportunities, and regular reports. I have provided reports and as much I was able to in the past. I will continue to do that and more in the future. TFN community members are the shareholders of our businesses, and of our governance activities. Tseshaht community must have more say in community agenda items, more information and input on important opportunities and decisions and more direct support for youth.

In my first government job my supervisor's belief was being a civil servant to mean the public paid the taxes for him to have a job serving them, and that he was to be civil when providing service. And interestingly enough, the word "Samurai" root meaning is "to serve". So, I see my role on council to serve our community, provide information community wants and needs, make sure our community has more input, questions, and give direction on important decisions. That is how it is supposed to be. That is what I offer, experience, fairness, reporting, community getting its voice back and giving direction given to leadership.
