# VIDEOGRAPHER

The Tseshaht First Nation is now accepting Expressions of Interest for a **Videographer** for our "Going Home Initiative" with the Beach Keepers Program. This is to work with the Beach Keepers on an as-needed basis for different projects throughout the year.

# POSITION SUMMARY

cišaa?ath (Tseshaht First Nation) is a vibrant community composed of over 1300 registered members whose hahuułi (traditional territory) includes from the Somass watershed including the entire Alberni Valley, the western portions of both Horne Lake and Cameron Lake, the Alberni Inlet and surrounding lands and watersheds to the Broken Group Islands of central Barkley Sound, and out to the Pacific Ocean. Tseshaht possesses Aboriginal Rights within the hahuułi, owned by our tayii hawił [ty-ee ha-wilth], including Aboriginal Title.

This is an exciting opportunity for interested experienced and emerging videographers to work with the Beach Keepers on an as-needed basis for different projects throughout the year. The purpose of this project is to support the production of media (eg. a video) that highlights cišaa?ath (Tseshaht First Nation's) "Going Home Initiative", which is supported by the Beah Keepers Program. The "Going Home Initiative" includes organized events or programs that support and preserve cultural heritage activities and traditional values of cišaa?ath (Tseshaht) people and serves to reconnect cišaa?ath (Tseshaht) members back to their homelands in such instances where this connection has been adversely impacted – directly or indirectly – by the actions of the Canadian federal government.

We have a budget of up to \$40,000 for this work.

# **CONFLICT OF INTEREST**

Respondents are asked to disclose in their EOI any actual or potential conflicts of interest and existing business relationships they may have with cišaa?atḥ (Tseshaht First Nation).

# **ORIGINAL WORK**

The videographer must guarantee that their artwork will be original and will not violate the copyright of any other individual or group.

The videographer shall defend, at its own expense, any action brought against cišaa?ath (Tseshaht First Nation) to the extent that it is based on a claim that the information, material and product supplied by the videographer under the agreement infringes on copyright, patent, design or any other similar right, and the videographer shall pay any cost and damages awarded against cišaa?ath (Tseshaht First Nation).

### COPYRIGHT

The videographer must be prepared to grant ownership and license of copyright right/reproduction rights of the work product to cišaa?ath (Tseshaht First Nation). The videographer shall retain the right to be identified as the creator of the work as well as copyright of the work. cišaa?ath (Tseshaht First Nation) reserves the right to edit and re-use the work as deemed necessary and appropriate.
