3. A signed Declaration Form, confirming that you are not presently bankrupt, and are in good financial standing with Tsashaht.

If the above requirements are not received by the Electoral Officer by **end of day November 3rd, 2024**, you shall be deemed to have declined the nomination for the Tsashaht First Nation 2024 Election.
