The listed nominees have been duly nominated for the offices of Chief and Council for the Tseshaht First Nation in accordance with the *Tseshaht Custom Election Code (May 15, 2024)*. The Electoral Officer will make best efforts to notify each nominee.

**ACCEPTANCE** – To become candidate in the Tseshaht First Nation 2024 Election, a nominee must submit the following to the Electoral Officer **no later than October 18th, 2024**:

1. A signed Acceptance of Nomination form, including full legal name, Membership number, mailing address, telephone number and e-mail address;
2. A Criminal Record Check, with no convictions, other than those for fishing or hunting or in the assertion or defence of Tseshaht Rights and Title;
3. A signed Declaration Form, confirming that he or she is not presently bankrupt and is in good financial standing with Tseshaht.

**WITHDRAWAL** - A Candidate may withdraw from an Election at any time by advising the Head Electoral Officer in writing. If a candidate withdraws on or before October 23, 2024, their name will not appear on the Ballot. If a Candidate withdraws after ballots are printed for an Election, votes cast for the withdrawn Candidate shall be void. The withdrawal form is available on the webpage listed at the bottom of this page.

**BALLOT NAME** – If you would like your name to appear differently than the way it is written on this preliminary list, please complete that section on the *Acceptance of Nomination form* found within the *Candidate Nomination Package* by **October 18, 2024**, and notify us of how you would like your name to appear on the ballot. The *Candidate Nomination Package* can be found on the website listed below. After that date, the ballots will be printed, and no further changes will be possible.
