Notice is hereby given that the **Tseshah** First Nation will hold a Nomination Meeting on **June 16, 2025**, in accordance with the *Tseshah Custom Election Code (2024)*, for the purpose of electors nominating candidates for the Office of one (1) Councillor for the remainder of the term of office, in a By-Election to be held on **July 29, 2025**.

IMPORTANT INFORMATION

Registered Members who are at least sixteen (16) years of age as of the date of the Election may nominate or second a candidate, and vote in this Election, and shall form the Voters List.

A Voter may nominate a candidate in-person at the Nomination Meeting OR by submitting a completed Nomination Form by either mail or email, which must be received by the Electoral Officer by 8:00 p.m. on June 16, 2025. The Nomination Form can be obtained from the Electoral Officer or downloaded from the webpage listed at the bottom of this Notice.

To be eligible for candidacy, a person must:

- a) be nineteen (19) years of age or older on the day of the Nomination Meeting (June 16, 2025);
- b) be on the Membership List or be entitled to have his/her name appear on the Membership List on the date that person is nominated;
- c) not be employed or contracted by Tseshah;
- d) have submitted a criminal record check and have no Criminal Conviction; and
- e) be in good financial standing with Tseshah and not be personally bankrupt.

To become a candidate, nominees must deliver the following to the Electoral Officer by **June 25, 2025**:

- 1) a signed Acceptance of Nomination form, including full legal name, Membership number, mailing address, telephone number and e-mail address;
- 2) a Criminal Record Check, with no convictions, other than those for fishing or hunting or in the assertion or defence of Tseshah Rights and Title;
- 3) a declaration confirming he or she:
 - i. is not presently bankrupt; and
 - ii. is in good financial standing with Tseshah.

The Election Code, supporting documents, and the official Voters List shall be posted and available during regular business hours at the Tseshah Administration Office Building; can be requested from the Electoral Officer; and will be available to download at:
